To confirm the minutes of the Town Council meeting held on 1st **February 2016**The minutes of the meeting held on 1st February 2016 were agreed and signed as a true record.

202 Announcements (For information only) To receive announcements from

- (i) The Town Mayor- The report of the Town Mayor was noted by the Town Council
- (ii) The Clerk- Mr T Foreman updated the Town Council on his activities during the previous month focusing on the proposed closure of Vane Close to incoming school traffic. Mr T Foreman explained that he had been contacted by a documentary company regarding the closure who were in attendance in case Members had any questions.
- 203 Public participation –To consider a motion to suspend the meeting to allow members of the public the opportunity to address the meeting limited to 3 mins each The Meeting was suspended following a proposal from Mr Mackie, seconded by Miss S Lawn.
 - (i) Norfolk Constabulary- Mr M Olesen provided an overview of the month's crime statistics. Mr Olesen explained the system for coding crimes within the town and gave a detailed breakdown of the areas crimes has been reported. The Town Council noted this report.
 - (ii) County and District Councillors For the County Council Mr I Mackie explained that the County Council had agreed a Council tax rise of 3.99% with a 2% rise for Adult Social Care. A number of cuts including library and Fire Station cuts were reversed. Mr N Shaw stated that he was due to attend high level meetings as part of his work with the Strategic Aviation Special Interest Group.

For the District Council Mrs T Mancini-Boyle explained there would be no precept rise and no reduction in services.

(iii) Members of the public- Mr M Martins spoke with regard to the River Green moorings and felt that the river bank could revert to natural rushes instead of continued quayheading. Mr I Mackie explained that the weight of the nearby major truck road and significant development meant if the quayheading should fail River Green may slide towards the river.

With regard to the Vane Close road closure, Ms R Harvie provided an overview of the types of documentary films Century Films Ltd had previously undertaken, insisting that their role was to observe rather than dramatize what was happening. Furthermore Ms Harvie explained that school parking is a major issue throughout the UK and felt that the approach of the Town Council was interesting and worthy of inclusion on a programme looking at problem parking. Miss S Lawn explained that the Town Council was not looking to vilify or cast blame, but purely draw attention to the issue of children's safety outside this school. The Town Council thanked Ms Harvie for her attendance and looked forward to working with Century Films Ltd.

207 Temporary Office Relocation

Mr T Foreman explained that the relocation of the Town Council office which was approved at the February 2016 Town Council meeting had been successfully completed within the past week. Particular thanks were offered by Mr Foreman to the office and amenities teams who managed the move seamlessly. The Town Council asked for gratitude for the efforts of the staff to be recorded in the minutes and noted this report.

208 Lease for St Andrews Football Club

The Town Council considered the report outlining the request from St Andrews Football Club for an additional 25 years to be added to its 9 year lease due to the grant funding requirements for tenure. Mr T Foreman explained that the extension and refurbishment plans by the Football Club had been supported in previous meetings by the Town Council and that there were no ongoing costs for the proposed lease extension. Mr P Berry explained that the Club was well supported within the town and Mr I Mackie felt that proposed plans would ensure its future viability. It was proposed by Mr I Mackie, seconded by Mr F Bowe and on a show of hands with all in favour **RESOLVED** to extend the lease by a further 25 years.

209 Bowls Club Lease

Mr T Foreman provided an overview of the draft lease proposed for the Bowls Club following the ongoing negotiations. Mrs T Mancini-Boyle stated support for the new lease as the terms appeared to strike the balance required for both the Bowls Club and the Town Council. Mr I Mackie felt that the terms were agreeable and that no variations on the draft lease were required. It was proposed by Mr I Mackie, seconded by Mr L Reeves and on a show of hands with all in favour **RESOLVED** to approve the signing of the new lease in due course with the Town Council seal to be attached.

210 Donation request from Cruse Bereavement Care

The donation request from Cruse Bereavement Care was discussed by the Town Council. Mr T Foreman indicated that there were funds available, however a Thorpe St Andrew based charity had indicated it may need investment in the forthcoming year to continue its work. There was much discussion about ways in which support could be offered to the charity including financial and logistical support. It was proposed by Miss S Lawn, seconded by Mr I Mackie and on a show of hands with all in favour **RESOLVED** to decline the funding request for Cruse Bereavement Care and earmark the remaining donation budget line into the 2016/17 budget line in case funds are required by the Thorpe based charity.

211 SAM2 Results

The results of the SAM2 signs which were located on Plumstead Road East. Mr L Reeves explained that many cars accelerate from the mini roundabout at the junction of Thunder Lane through Plumstead Road East. Mr I Mackie stated his surprise at the instances of vehicles travelling in excess of 70mph on a 30mph restricted road and asked that an article be included in the next edition of Thorpe St Andrew News regarding this. Mr M Pickess asked for the next SAM2 location to be the Ring Road, Mr T Foreman confirmed this would be the case. This report was noted by the Town Council

Report from Councillor John Ward

Broadland District Council

Broadland was ranked as the most peaceful local authority area in the UK by the Institute for Economics and Peace in their inaugural UK Peace Index in 2013.

Grants of up to £1000 are on offer to community groups in Broadland for projects that improve the energy efficiency of a building. Details from the Energy Team at BDC energy@broadland.gov.uk

Norfolk County Council

A new joint initiative has been launched by Norfolk Fire & Rescue Service and East of England Ambulance Service which will see fire personnel mobilised, instead of the police, to force an entry where necessary when there is concern for the welfare of a patient inside a property.

Norfolk Museum Service has been shortlisted in the Education category in the Museum & Heritage Awards. This is very much the Oscars of the heritage industry and the winners will be announced on 18th May in London.

As the nation gets ready to celebrate the 400th Anniversary of Shakespeare's death, Norfolk Library Service will be promoting "Shakespeare Rewritten". A promotion of 20 modern books inspired by his popular stories. The promotion runs until 16th April.

On 22nd March, I attended the Youth Parliament election result at County Hall. 40,000 of those eligible, voted, a 51% turnout. There were 27 candidates for the 9 vacancies. The successful candidate for Norwich North was Charlotte Snell with 1141 votes with her nearest rival getting 1012 votes.

Devolution – highlights of the current offer:-

- -£1.6 billion of new money to support economic growth over the next 30 years. £65m per year for the next 5 years then £30m thereafter.
- -Region to take control of devolved transport budget.
- -New powers over infrastructure, developing skills for employment and improving our health and social care system.
- £175m of capital grant for new homes.
- -A combined authority chaired by an elected mayor and a cabinet of elected representatives from the partner authorities.
- -The draft agreement will now be debated in each of the Councils in the Region.

This report has been prepared for the Town Council to choose its preferred contractor for parks and amenity waste removal for 2016/17.

Background

The Town Council owns approx. 22 litter bins and 16 dog bins across the Recreation Ground, Fitzmaurice Park, River Green and the Tree Plantation. The contents of these bins are emptied and disposed of on a weekly visit by the current contractor.

Result

As the beginning of the new financial year begins the contract renewal is due. Three quotes have been sourced for the current 1 weekly emptying and disposal. Costs are for given for the two main parks (Recreation Ground and Fitzmaurice Park) as River Green is excluded for comparison.

The quotations for the existing contract frequency is as follows

NOTICE OF DECISION

On the 16 October 2013 the Norfolk County Council registered an application submitted by Thorpe St Andrew Town Council, Dussindale Centre, Pound Lane, Thorpe St Andrew, NORWICH, NR7 0SR for the modification of the Definitive Map and Statement of Public Rights of Way by the addition of a footpath in the Town of Thorpe St Andrew. The path is shown as a bold black line on the attached map.

Norfolk County Council hereby give Notice of their Decision to make an Order under Section 53 of the Wildlife and Countryside Act 1981 on the basis of:

S53(3)(b) the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path or a restricted byway.

S53(3)(c)(i) of the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path or a restricted byway.

The Order, if confirmed, will modify the Definitive Map by the addition of a <u>public</u> <u>footpath</u> running from the A1242 Yarmouth Road to Thorpe St Andrew Footpath No. 5.

Notice of the making of the Order will be given in accordance with Schedule 15 of the said Act.

If no objections are received the Council will confirm the Order. If any objection is duly made and not withdrawn, the Council will submit the Order to the Secretary of State for Environment, Food and Rural Affairs for confirmation.

INFORMATIVE NOTE

This note is not a formal or complete representation either of the Council's position or of the law. It serves to set out some of the central issues which informed the Council's decision. A fuller report is held on the County Council's files. You may wish to seek your own legal advice upon the issues raised.

Having considered all the legal tests, the County Council has decided **to make** an Order in this case. Among matters considered by the Council in making this decision are the following:-


The County Council was provided with a sufficient amount of evidence of frequent public use of the route on foot covering a relevant 20 year period and beyond with no evidence of challenge.

The County Council also carried out research considering historic maps and other documents. The Bryants' Map of 1826 shows the route leading to a foot ferry. The Railway Deposit Plans of 1859 describe the route as 'Road and Footpath' owned, along with others, by the Surveyors of Highways. In the Railway Plans and Reference Book, Parliamentary Session of 1864 the route is described as a Public Footpath owned by the Surveyors of Highways. The altered Tithe Apportionment of 1892 shows the route coloured in the same way as other routes we now know to be public and the 1910 Finance Act Valuation plan show the route as uncoloured which can suggest public status as well as a route used for access by multiple properties.

All this evidence taken together with the evidence of use are suggestive that public footpath rights exist along the route and therefore support the addition of the route as a public footpath to the definitive map and statement.

Next Steps - The Council will shortly make the Order which will be copied to you with a covering letter. The letter will set out the next steps in case you want to object or support the Order.

First World War centenary oaks

Reason for this Report

This report has been prepared to update the Town Council on the progress of the World War One Centenary Memorial planned for River Green.

Background

To mark the centenary of World War One 5 oak trees (*Quercus Robur Fastigiata Koster*) and a garden of poppies will be planted at River Green, with each tree representing those who lost their lives in each year of the First World War.

Result

A planning application with plans and a design statement (see Appendix A) was written and submitted by the Town Amenities Officer to the Broads Authority and has subsequently been accepted with planning approved. It is anticipated that work will be carried out and complete by December 2016, with the oaks being purchased alongside the Park trees previously agreed by the Town Council for the Fitzmaurice Park.

Advice

There is no advice for this item.

All decisions and actions taken by or on behalf of Thorpe St Andrew Town Council must (1) be within the local powers of the Authority; (2) comply with any procedural requirement imposed by law; (3) be within the powers of the body or person exercising powers on behalf of the Authority; (4) be undertaken in accordance with the Authority procedural rules inc. Standing Orders and Financial Regulations; (5) be fully and properly informed; (6) be properly motivated; (7) be taken with regard to the fiduciary duty of the Authority to its residents; and (8) be reasonable and proper.

Appendix A

DESIGN AND ACCESS STATEMENT

This statement has been prepared in support of the application for Works to Trees in a Conservation Area to fell a total of six category B trees identified by tags 03981 – 03986. The area will then be redesigned to form a permanent 'Garden of Remembrance' to mark the centenary of the fallen military personnel and civilians of the First World War.

The garden will consist of circular 'wild flower' area planted with Poppies (*Papaver Rhoeas*) with a semi-circular backdrop planting of five Oak trees (*Quercus Robur Fastigiata Koster*); each tree representing the sacrifices of both military and civilian lives lost for the individual years of 1914-1918 inclusively.

The application follows pre-application advice given following site meetings held with Mr S Haydon with the present visual/amenity value and retention of the existing 'B' category trees in mind. The design/concept has strong support from Thorpe St Andrew Town Council, it's residents, the Royal British Legion and the Combined Services Association.

APPLICATION SITE APPRAISAL

The application site is a council owned recreational river frontage used by the general public including visiting holiday boat traffic and customers of the Great Yare Ferry Company that provide river bus tours from the guay heading to and from Norwich and the Whitlingham Country Park.

DESIGN PROPOSAL

The aim is to achieve a sustainably durable low maintenance and high quality designed recreational space that fulfils the councils and its resident's wishes to commemorate the centenary of the end of the First World War and remember those that gave the ultimate sacrifice.

The following considerations have therefore been taken into account:

- 1. The Poppy (wild flower) area supports the internationally recognised symbol of remembrance
- 2. The international aim to commemorate the centenary of the First World War
- 3. To provide a permanently accessible memorial facility to complement the existing Thorpe St Andrew War Memorial.

HIGHWAY CONSIDERATIONS

There are no Highway considerations relevant to this proposal, existing access points will be used.

TREES AND HEDGES

All other trees are to be retained. No additional landscaping will be required.

FLOODING

The site provides moorings to the River Yare and as such the Environment Agency website details that there are flooding implications.

ACCESS

The proposals will not lead to any increase in traffic. It is therefore considered to be a sustainable use of the site. Additionally the council wishes to install a three hooped design cycle stand to encourage visitors to use cycling as an alternative method of transport to the locality.

CONCLUSION

The application and proposed design presents a scheme that is both sustainable and appropriate to the setting of the site and its use.
