1 MINUTES

The minutes of the Annual Public Town Meeting held on 13th May 2019 were agreed as a true record. Proposed Mr Snelling, seconded Mr Ward.

2 ANNUAL REPORT OF THORPE ST ANDREW TOWN COUNCIL FROM THE TOWN MAYOR, COUNCILLOR JOHN FISHER

Mr Fisher presented a comprehensive report of the Council's work during the previous two years, noting the significant impact of Covid-19 throughout 2020. He expressed thanks to councillors, staff, Father James and the residents of Thorpe St Andrew for the resilience and community spirit shown throughout the pandemic, and for the ingenuity demonstrated in adapting to restrictions.

Ongoing matters with River Green continue to be investigated and applications for the development of the Langley School, Pinebanks and Oasis sites are likely to return to planning in the near future.

3 FINANCE

- (i) Financial Statement 2020/21 members noted the Financial Statement for 2020/21. The Clerk gave the apologies of the Responsible Finance Officer (RFO) and suggested that any queries could be taken up with her via email.
- (ii) Variance Report 2020/21 members noted the Variance Report for the period 1/4/20 to 31/3/21 and were again advised to follow up any queries with the RFO.

4 UPDATE FROM LOCAL ORGANISATIONS

(a) Fr James Stewart, Thorpe St Andrew Parish Church – Father James acknowledged a time of continuous community engagement and highlighted the collaboration of the Town Council and the Church with civic services and events. The Parish adapted quickly to Covid restrictions and was one of the first to offer online services which connected to parishioners worldwide. The

church worked hard to assist isolated members of the community during the pandemic and raised funds through a plant sale and the publication of a recipe book. Work on the church wall and cemetery extension will continue this year and social events are planned from June.

- (b) Norfolk Police PC Andy Mason discussed the changing role of Beat Managers due to Covid and the further new initiatives, including the "Park, Walk, Talk" scheme. He discussed current issues involving Thorpe High School, speeding and River Green but reported that the only rise in crime figures in the area was with graffiti.
- (c) Royal British Legion Mr Snelling discussed the current work of the Royal British Legion both nationally and locally. Whilst all events had been banned due to Covid, the Thorpe Branch, in conjunction with the Town Council and Early Help Hub, co-ordinated a response for residents needing assistance due to the pandemic, receiving nearly 100 requests per week at the peak. Funds of £1,300 had been received during the year with £500 donated to the Poppy Appeal and £500 to the Legion Nursing Home in Cromer.
- (d) Thorpe History Group The group had been unable to meet since February 2020 but had kept in touch with members using newsletters and social media. They had published their first book and outlined their talks scheduled to take place from June.
- (e) Thorpe St Andrew Dementia Café a written report had been circulated with any questions to be submitted to the Communities Officer.
- (f) Thorpe St Andrew Trust a written reported had been circulated.

A written report from the Dussindale Community Centre will be circulated after the meeting and be added to the website.

5. PUBLIC PARTICIPATION

The meeting closed at 8:04pm

A question was asked relating to the progress of the Neighbourhood Plan and concern raised as to standards at the River Green. The Town Mayor explained the next steps for the Neighbourhood Plan, including community engagement and consultation with statutory bodies, and confirmed that River Green remains a priority matter for the Town Council, with regular meetings with fellow stakeholders ongoing.

Crime Figures – From 01/01/2022 to 20/04/2022.

There have been 151 Crimes raised in total.

Crimes of note -

3 x Arsons.

- 1. Oasis Leisure Centre.
- 2. Approximately 100m2 of Woodland on Racecourse Plantation.
- 3. Skirmish Paintball outbuilding.
- 1 x Cannabis grown found in a Dwelling.

13 x criminal damages.

In relation to the Arson at the Oasis. We have received calls about youths getting into the building, before the fire and since the Arson occurred. This is still under investigation.

Myself and my colleagues have patrolled the area as often as possible over the Easter holidays. I have spoken to the owners of the Oasis, who are now going to look at demolishing the building as soon as possible.

Speeding -

Speeding is once again our Priority. We have been carrying out speed checks and will continue to do so, on St Williams Way, Thunder Lane, Harvey Lane and Dussingdale Drive.

We are aware of the near miss at the Zebra Crossing on Thunder Lane. We have carried out our own risk assessment of the crossing and feel some improvements could be made. We have filed a report to the relevant department highlighting our recommendations.

Initiatives being targeted for this year -

We held our Priority Setting Meeting for the area on 28th March.

The following priority was set:

Speeding and Road Safety.

On March 16th we spent 2 hours in the entrance of Sainsburys on Pound Lane in Norwich conducting a Street Surgery engaging with members of the public face to face and answering any concerns they had. We will be holding another community engagement day at Salhouse Garden Centre on the 21st May 2022. Dussindale Park Community Trust report for 2022 Annual public Meeting

The Trust owns and hires the Dussindale Community Centre, Pound Lane to provide its income. The last financial year 2021 – 2022 saw the community centre open every month following the previous year when it had only been open for three months in all due to the covid lockdown.

The Redeemed Christian Church of God was the largest individual source of income to the Trust for many years but during the lockdown they secured a long held ambition of establishing the church elsewhere in premises that were exclusively for their church's use.

A government restart grant of £8000 offset some of the loss of church income in the short term and the Centre has attracted a number of new users. Rising energy costs are a concern that will inevitably lead to an increase in hire charges.

A bus shelter that was erected on the Trust's property by Sainsbury's some 12 years ago was demolished by a First bus. After a year of wrangling with Sainsbury's caretaker manager Jonathan Emsell took ownership of the shelter from Sainsbury's to the Trust which then enabled First Bus insurers to erect a new bus shelter which has been much appreciated by the community.

In summary there is a difficult year ahead but with a string user base the Community Centre expect to provide a comprehensive range of facilities that appeal to users of all ages form parent and baby groups, aerobic groups, dancers through to activities that appeal to retired people. Not forgetting our large number of badminton players that increase in numbers every year.
