The minutes of the meeting held on 3<sup>rd</sup> October 2022 were agreed and signed as a true record.

Miss S Lawn explained she had attended the Broadland District Council Chairman's Civic Service, raised the flag to launch the local Poppy Appeal, and judged the recent Town Council Pumpkin competition.
- (ii) The Clerk Dr T Foreman updated the meeting his activities throughout the month, many of which appear on the agenda of this meeting.
- 5 PUBLIC PARTICIPATION –TO CONSIDER A MOTION TO SUSPEND THE MEETING TO ALLOW MEMBERS OF THE PUBLIC THE OPPORTUNITY TO ADDRESS THE MEETING LIMITED TO 3 MINS EACH

The Meeting was suspended following a proposal from Miss S Lawn, seconded by Mr S Snelling.

(i) Norfolk Constabulary – The Locum CEO provided an overview of the work undertaken by the Safer Neighbourhood team over the past month and details of the move to Broadland Police Station. The attendance of the Police at the recent Town Council Firework Display was welcomed.

- (ii) County and District Councillors The meeting noted to the report of Mr J Ward. Mrs T Mancini-Boyle provided details of grants currently available from Broadland District Council, including the 'warm rooms' initiative to deal with the rising cost of living.
- (iii) Members of the public None

#### 6 FINANCE

- (i) Payments List was agreed and signed as a true record.
- (ii) Bank Reconciliation Statement was agreed and signed as a true record.

#### 7 DRAFT MINUTES OF COMMITTEE MEETINGS.

#### 8 BUDGET 2023/24

The Town Council received the draft budget which had been recommended for approval by the Finance and Staff Committee. Dr T Foreman provided details of the draft budget and explained that the proposed rise was significantly less than the rate of inflation, and resulted in a rise of approx. £3.07 per year on a Band D property. Dr T Foreman explained that this figure would be adjusted for the exact tax base, but ensured the Town Council could continue to provide the existing service level and progress projects including improvements to the workshop facilities. There was significant discussion relating to the current rate of inflation, projected to be in excess of 12%. The proposed rate of precept increase was approx. 3% which the meeting felt represented good value. It was proposed by Mr J Ward, seconded by Mr S Snelling and on a show of hands with all in favour **RESOLVED** that the budget be adopted in full, with a required precept of £550,654.00.

#### 9 DISPOSAL OF ASSETS

The Town Council received the report of the Parks and Estates Supervisor, which detailed a total of 18 pieces of parks machinery which were no longer required. Dr T Foreman explained that a replacement for the existing John Deere Gator was required and so funds from this sale would help offset the cost. It was proposed by Miss S Lawn, seconded by Mr M Lake, and on a show of hands with all in favour **RESOLVED** that the disposal of assets be approved, with the Town Mayor and locum CEO authorised to sign the disposal of assets forms.

#### 10 LGA MODEL CODE OF CONDUCT

Dr T Foreman introduced draft LGA Model Code of Conduct. There was widespread support for the new Model Code of Conduct. It was proposed by Mrs T Mancini-Boyle, seconded by Mr F Bowe and on a show of hands with all in favour **RESOLVED** to support the adoption of the LGA Model Code of Conduct by Broadland District Council, and for the Town Council to then look to do so.

#### 11 PERFORMANCE UPDATE

Dr T Foreman provided an overview of the current performance data for the Town Council, including social media performance data which had been prepared by the Community and Communications Officer. The Town Council welcomed the information and noted the significant increase in emails during the last quarter. The performance update was **NOTED** by the Town Council.

The Town Council had a wide-ranging discussion about cricket provision and there was significant support for community cricket to continue at the Fitzmaurice Park. It was proposed by Mrs T Mancini-Boyle, seconded by Miss S Lawn and on a show of hands with all in favour **RESOLVED** that the existing offer to the Cricket Club be the last and final offer.

#### PARKS AND ESTATES REVIEW AUGUST TO NOVEMBER

Here is the parks and estates review for August to November.

The tail end of the summer was a very warm and dry period of weather, the Sir George Morse Park and the Fitzmaurice Park resembled deserts until the end of September.

Football should have resumed in the middle of August but due to the extreme conditions I took the decision to delay the start of the season until the first weekend in October. This caused a few issues with the teams but all in all they agreed it was the best option, to preserve the pitches for the long term.

I also liased with TSAFC about moving their pitch over to the back edge of the field, again to give the traditional A1 pitch a chance to recover. They again agreed and could see the benefits for the future.

At the end of September we overseeded the entire field, timed perfectly with the first rains and still warmth in the ground. James carried out these works as unfortunately I had to have time off due to covid. The result of this overseed has been outstanding, many of the clubs have said it's one of the best playing surfaces in Norfolk. I am hoping that building up relations with the football clubs can help both parties in the future. As an aside to this I have also been in contact with Norfolk FA in regards to getting extra funding for different projects.

James and Martin attended and passed the ROLO (Register of Land Based Operatives) course. This is a course similar to the CSCS qualification for builders and covers health and safety among other things.

The cricket season ended at the end of August. Bystanders won the 20/20 tournament at Horsford and I believe the season was a success for them. No games were called off due to weather or other issues which is very unusual. Future plans for cricket are still being discussed .

The planner has proven very effective with all members of the team. Over 900 jobs have been completed between April and November.

Verge cutting has continued as the weather has remained mild, hopefully one more cut will see the season out.

CGM our tree contractor has carried out a number of projects at the Fitzmaurice Park including pollarding Field Maples near Hopton Close and removal of Poplars in the Pound Lane plantation. This is the start of our planned tree works program for the winter months around the park. Information and guidance will be published on social media to make the community aware of what is happening.

We have received a number of tree packs from the woodland trust which will go towards hedge planting around the town. We have also received a grant of £645 for more hedging again for around the town.

November has turned into events season this year with fireworks at the beginning and Christmas lights at the end. The planning of the events by Rachel and Debbie has made our jobs on the parks team so much easier, we all just click into place and the plans come together. This shows by how successful our events have become.

May I take this opportunity to wish you all a Merry Christmas and a happy 2023 from the whole parks and estates team.


