The minutes of the meeting held on 24 July 2023 were signed and approved as a true record.

4 ANNOUNCEMENTS (For information only)

- (i) The Town Mayor, on behalf of the Council, welcomed Michelle Barron to her first Town Council meeting, as the new CEO/Town Clerk. Welcome was also extended to Mel Friend the newly elected councillor for the North West Ward and congratulations to Cllr Berry, recently elected as District Councillor. The Town Mayor also expressed his thanks to the officer team for a very successful 'Street Food' event, which took place on Sunday 10 September.
- (ii) The Town Clerk confirmed the Neighbourhood Plan consultation had been received and it will be included on the next agenda for discussion.
- (iii) The RFO advised the Council that Dr T Foreman, on his last day as Town Clerk, authorised the removal of the old solar panels on the Town Hall roof.

5 PUBLIC SESSION

It was proposed and duly seconded that the meeting be suspended to allow members of the public to address the meeting.

- (i) Norfolk Constabulary No report but it was noted that the Community Officer attended the 'Street Food' event.
 - (ii) County and District Councillors Members noted the report from Cllr Ward.
- (iii) Members of the public One member of the public wished to highlight the problems and health implications the long grass on verges can cause for dogs. Also raising, for the attention and support of those serving as District Councillors, the ongoing smell emulating from Whitlingham sewerage works and the frustration at the lack of any response. Another member of the public raised concerns over the parking on South Avenue, unclear road markings and vehicles speeding through Yarmouth Road, requesting that these issues are chased up with County.

Father James updated Members on the most recent and upcoming church events. Also advising Members of the funeral arrangements for John Preus on 22 September; recipient of a Thorpe St Andrew Civic Award in 2021.

6 **EVENTS UPDATE**

Mrs R McCarthy shared with Members the success of the Street Food event, although extremely hot, there was a very good turnout with no reported problems and financial information to follow. An update was given on the position of future Council events; all are proceeding as planned.

Cllr Eden and Cllr Emsell extended their congratulations to Mrs R McCarthy and the rest of the team and volunteers, on the success of the Street Food event, which was well attended considering other events being held on the same day.

The Deputy Mayor gave an update on the Remembrance Day Parade, which will be the same format as previous years but a shorter route, starting at Whitlingham Lane. There will be adequate parking along Yarmouth Road, as both sides can be used including the car park at Roxley Hall.

7 PARKS AND ESTATES UPDATE

Mr J Calver gave a verbal update on all the works over the summer including the newly planted roundabout, overseeding of the football pitches at the Morse, trees planted are thriving.

All Parks Team staff completed a RoSPA operational plan inspection course earlier in the year, trained to an operational level, able to identify playground defects. Resurfacing of the play equipment area to begin, ready for use again by half term.

The Town Hall roof was completed on time, the solar panels were removed but will look to getting a grant to replace in the future.

The Broads Authority have refused the application put in for the Horse Chestnut tree at River Green, an appeal has gone to the Secretary of State.

REPORT FROM COUNCILLOR JOHN WARD

NORFOLK COUNTY COUNCIL

i was honoured to be present at the Battle of Britain Ceremony at County Hall on 15th September. We had a fly past by a Spitfire that is the only one still flying that saw action in the Battle of Britain.

200 Firefighters will take part in a giant relay, night and day, over 385 miles between all 42 fire stations in Norfolk. It starts on Thursday 28th September and finishes at Carrow Station on Sunday 1st October.

A new website has been launched, <u>www.travelnorfolk.co.uk</u> to bring together details of all public transport and cycling and walking routes.

The final round of LED upgrades to NCC's street lighting has started and will be completed within the next 2 years, when all 16,800 lights will use low energy LEDs, saving over 200 tonnes of CO2 emissions per year, plus there will be an electricity saving of £380k per year on current prices.

Norfolk County Council are offering residents 40,000 discounted trees. This will help towards our target of one million trees. Trees will be available for collection from County Hall. Details at www.norfolk.gov.uk/subsidisedtreepacks.
