

**Norfolk County Council (Postwick with Witton)**  
**Urgent Notice**  
**Temporary Traffic Regulation Order 2025**  
**Section 14(2) of the Road Traffic Regulation Act 1984**

Postwick with Witton (NTRO9686) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to resurfacing works the use by vehicles (of any class) of the A1270 Broadland Northway from its junction with A1270 Link Road roundabout to its junction with Thorpe End Drive roundabout (the "Road A") and A1194 Poppy Way from its junction with Poppy Way roundabout to its junction with Broadland Northway roundabout (including the roundabout) (the "Road B") in the Parish of Postwick with Witton will be temporarily prohibited/restricted.

The closure/restriction is necessary or expedient because works are being or are proposed to be executed on or near the Road.

The closure/restriction is anticipated to take place between 20:00 and 06:00 from 19<sup>th</sup> to 23<sup>rd</sup> May 2025.

This Notice shall be in effect from 19<sup>th</sup> May to 23<sup>rd</sup> May 2025 or until the closure/restriction no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works when the closure/restriction is no longer necessary or otherwise on the 23<sup>rd</sup> May 2025 without further notice.

If necessary, this Notice may be extended for a maximum of 18 months from the date this Notice is effective by an Order.

Alternative route is via: Broadland Northway - A1270 Broadland Northway, A1042 Yarmouth Road/ Ring Road/ Saint Williams Way/ Heartsease Lane/ Mousehold Lane, A1151 Wroxham Road, A1270 Broadland Northway A1194. Poppy Way - A1194 Poppy Way/ Broadland Way (Rackheath, Sprowston, Thorpe St. Andrew, Postwick with Witton, Great and Little Plumstead).

The works promoter for this restriction/closure is: Norfolk County Council.

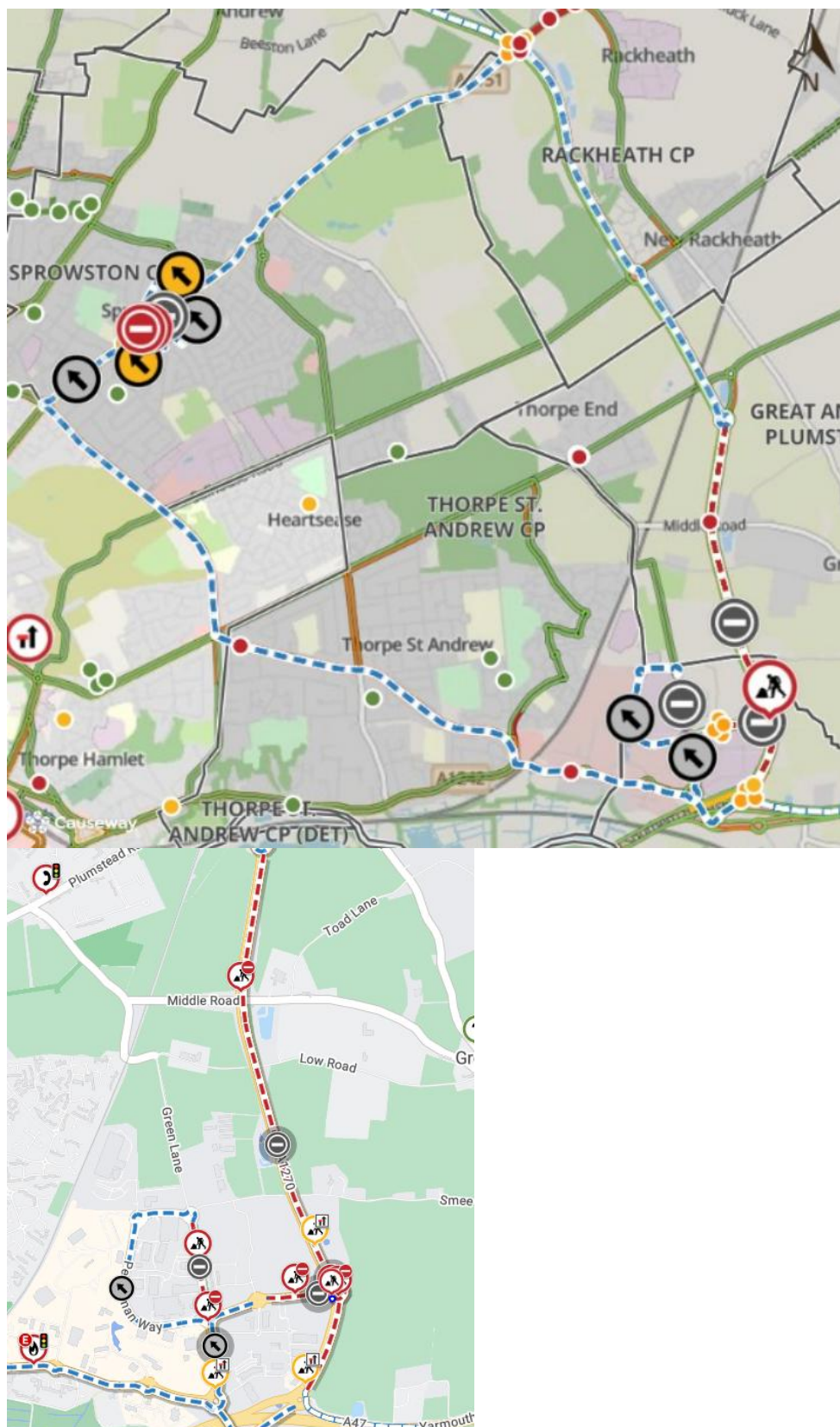
A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
