Urgent Notice
Temporary Traffic Regulation Order 2025
Section 14(2) of the Road Traffic Regulation Act 1984

Thorpe St. Andrew (NTRO9755a) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to BSIP carriageway improvement works the use by vehicles (of any class) of the A1242 Yarmouth Road from its junction with A1042 Ring Road for 210m westwards (the "Road") in the Town of Thorpe St. Andrew will be temporarily subject to a one-way restriction (eastbound only) allowing traffic to only travel westbound.

The restriction is necessary or expedient because works are being or are proposed to be executed on or near the Road.

The restriction is anticipated to take place from 2nd to 6th June 2025.

This Notice shall be in effect from 2nd to 6th June 2025 or until the restriction no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works when the restriction is no longer necessary or otherwise on the 6th June 2025 without further notice.

If necessary, this Notice may be extended for a maximum of 18 months from the date this Notice is effective by an Order.

Alternative route is via: Northbound: Yarmouth Road, Thorpe Road, Carrow Road, A147 Carrow Road, Koblenz Avenue, King Street A1054 Bracondale/ Martineau Lane, A146 Loddon Road, A47, A1270 Broadland Northway, A1042 Yarmouth Road. Soundbound: A1042 Ring Road, Saint Williams Way, St Williams Way, B1140 Plumstead Road, Ketts Hill, A147 Bishop Bridge Road, Riverside Road, Riverside, Koblenz Avenue, Canary Way, Carrow Road, A1242 (Clarence Road, Thorpe Road, Yarmouth Road) (Thorpe St. Andrew CP (DET), Norwich City, Postwick).

The works promoter for this restriction and closure is: Norfolk County Council.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

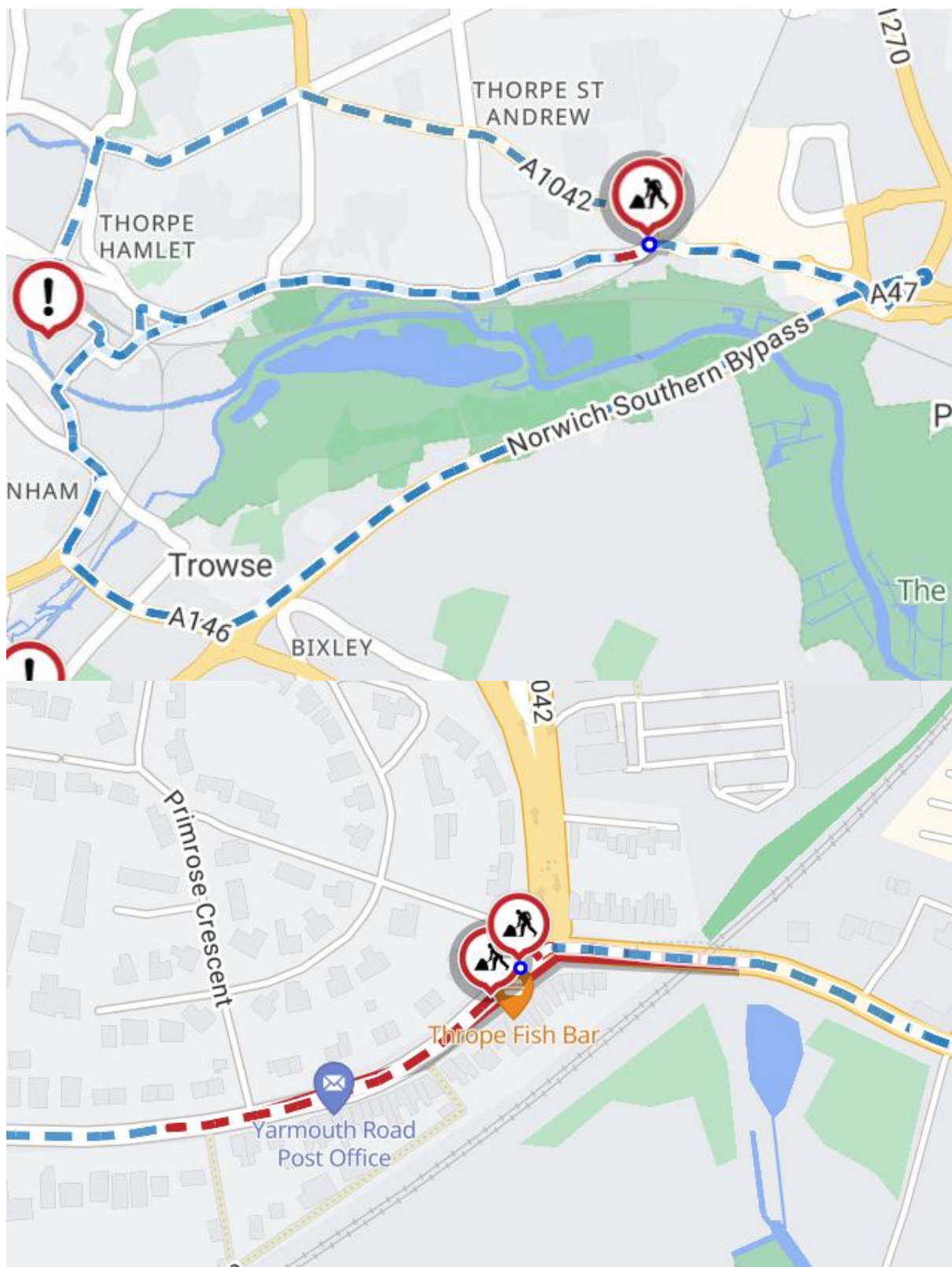
